## Freedom of Information Act Request Response No. 01052016-1

## Question

- 1. What was the age range of children you reported to the ONS who were a victim of a sexual offence (as this sometimes seems to differ in the above report from under 16s to under 18)
- 2. What were the child victims gender (total number per gender or in percentage terms please)
- 3. What percentage of your reported cases was the offender known to the child victim at the time the offence was reported
- 4. What percentage of the cases was the child victim unaware of the offender until the offender was caught and their identity then revealed that the victim knew the offender
- 5. What percentage of the child sex offence cases were committed by females
- 6. What percentage of the child sex offence cases were committed by males
- 7. What was the average age of the child sex offender (and by gender)
- 8. What percentages by ethnicity was the child sex offender and child victims
- What was the relationship of the child sex offender to the victim (ie percentages whether mother / father / carer / friend / family friend / professional worker such as teacher / other
- 10. How many of the reported sexual offence cases were against a child by a child / young person (and what was this age range and/or average age together with genders and ethnicities)
- 11. What percentage of the cases happened within the year reported and what percentage were reported historical cases

- 12. What percentage of the child sex offence cases were committed by reoffenders
- 13. What percentage of the child sex offence cases have led to convictions and imprisonment, ie what was the sentencing (and how many cases were dropped by the courts/police due to insufficient evidence and/or withdrawal from victim to pursue the case or for 'other reasons')
- 14. If known, what support/treatment has the victim received since the crime committed

## **Answer**

The Office of the Northamptonshire Police and Crime Commissioner (OPCC) and Northamptonshire Police are two separate legal entities.
